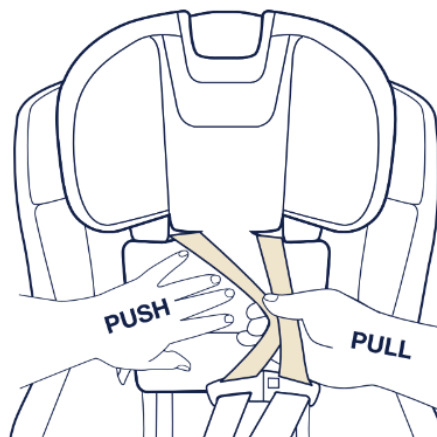
Dear Valued Retail Partner,

Nuna Baby Essentials, Inc. (Nuna) has decided that a defect which relates to motor vehicle safety exists in the Nuna Rava Convertible Car Seats manufactured between July 16, 2016, and October 25, 2023. The defect is a result of debris entering the area where the front harness adjuster button is located. The debris may cause the teeth of the adjuster mechanism to no longer properly clamp onto the adjuster strap, resulting in the harness no longer remaining tight. A loose harness may not properly restrain the occupant, increasing the risk of injury in a crash.

Nuna is working with NHTSA on this voluntary recall. Owners of affected Ravas can register to receive a free remedy kit which will consist of (i) a new seat pad (including installation instructions), (ii) instructions for checking harness functionality, and (iii) if harness functionality is impaired, instructions for properly cleaning the harness adjuster area. The new seat pad design will cover the plastic harness button area and help prevent debris from entering the harness adjuster mechanism.

Until consumers receive the remedy kit, they may continue using their RAVA car seat as long as the harness is properly securing the occupant consistent with the existing instruction manual and labels.

Consumers can check the performance of the harness by pushing on the seat back with one hand and pulling the harness straps firmly with the other. The harness should stay locked and not lengthen when performing this test.



If the harness lengthens while performing the test, consumers should STOP using the seat and contact Nuna immediately.
